The City of North Bonneville charges residents a fee of \$15 for ½ day usage or \$25 for full day usage plus a \$50 deposit. Non-residents are charged a fee of \$40 for ½ day usage and \$50 for full day usage plus a \$50 deposit. This fee is for, but not limited to: replacement of equipment, clean up, maintenance, labor and/or repair. The deposit will not be refunded if the reservation is canceled.

**Refunds are available after the City Council has reviewed and approved the refund. This review takes place during the second council meeting each month. Refunds are available the following day.**

The fee is charged for use of the gazebo only and not the surrounding park area which is available without charge.

Serving of alcohol may require a liquor license

**Gazebo Rules:**

- Use the facility at your own risk
- Be courteous to park visitors
- Keep pets under control and pick up after them
- Please keep the gazebo facility and adjoining park areas clean
- Vandalizing the gazebo is a serious offense and will be prosecuted
- Park in designated parking areas
