City of North Bonneville Snow Plowing Policy

The city staff will clear the city roads of snow accumulations exceeding four [4] inches and/or as safety need dictates this removal action.

The Public Works Supervisor will monitor weather forecasts and coordinate snow removal activities as needed. Contractors on the approved contractor's list will be relied upon for snow removal services, provided the need for their service arises. The Public Works Supervisor will assess the snow accumulation rate and has authority in calling approved contractors for emergency snow removal in the event accumulations exceed the capacity of city staff to manage. The Public Works Supervisor will designate the areas contractors are to focus snow removal services as prioritized in the Snow Plowing Policy.

The Public Works Supervisor and staff will work closely with the Fire Chief or his/her designee and respond at his/her request to open any areas where emergency services need to access. City staff will not plow private property, businesses or parking areas but are authorized to plow a lane where fuel is obtained allowing access for fueling snow plows, snow removal equipment and emergency response vehicles. Public Works may incur overtime expenses with verbal administrative approval.

Snow removal will follow the North Bonneville Snow Plowing Policy and be prioritized according to the following schedule:

Priority #1

Public Works site, Fire Department, West Cascade, East Cascade [to Shelly Lane], Bonneville Dr. entrance, Dam Access entrance, Garrison and Evergreen to Highway 14.

Priority #2

Roads, streets, cul de sac's, lanes, courts and the municipal parking lots will be plowed. Catch basins cleared and opened to minimize water infiltration to sewer system.

In an advance warning of a snow fall event, an effort will be made to tag vehicles for removal from city roadways. Parked vehicles on city streets – placed as to impede snow removal may result in that street not being plowed. An effort will be made not to plow in driveways as part of the snow removal process.

During a snow event the Public Works Supervisor and Fire Chief will provide a status update to the Mayor hourly or as often as needed.

7	Open Talema
	Priority 2
8	Plow Cul de Sac's, lanes, courts, Warren Rd, Grenia Rd, all sub division streets, Roosevelt, Look-In-Lane, Lakeside Way, Lakeside Court, Shady Oak, Wana Lake Rd to Gate
9	Plow Municipal parking lots
10	Clear Catch basins to minimize water infiltration in sewer system

11	Open roads from curb to curb
12	Deep Snow: Fire Hydrant clear snow (Fire Volunteers to help if possible)
