New Business

- Councilor Bianchi initiated discussion about watching Frisbee players pile limbs out of the way to play and there are still widow makers overhead (broken limbs still hanging). Do we need to have more insurance for the recreation areas?
- Attorney Woodrich stated that since we don't charge a fee the city has recreational immunity, people using recreational areas do so at their own risk, however, we need to do limb clean up ASAP.
- Resolution 499 amending city fees was discussed. Attorney Woodrich will look into recreation liability and city
- Stevens stated the problem arose from wind storms, snow and 2 ice storms. Disposal is happening, however, it may be into September before work is complete. Trees are tagged with ribbon for keeping, pruning, or removal.
- Administrator Hughes has a call in to WCIA city insurance relating to these items who recommended signage.
- A Guest presentation was given by Devin Jackson, owner of Jackson Civil Engineering. The roads of Cascade Drive East and Evergreen drive will be narrowed during construction. Stevens and Forester had concerns of an abrupt edge. Jackson explained the rebuilding technique of grinding existing asphalt into the base. Once finished there will be a mild sloping edge of gravel on both sides of the roads.

City Administrator's Report

I'd like to introduce Dawn Thompson, our new Clerk/Fiscal Support Specialist. We are thrilled to have her.

Starting the financial reports for March- usually takes about 10 days

ATU negotiations started last week.

Skamania County Transportation Council meeting:

Port update:_ the Stevenson waterfront is eroding so they are submitting a grant application to build up the waterfront and eventually to pave a pathway on it. They have been working on this project for 10 years (due to permits with Tribes, Corps, Fish & Wildlife) and TAP (Transportation Alternatives Program) may likely fund the grant. TAP funds are for pedestrian projects.

Bingen/White Salmon Project: They received funding to do a downtown transportation study and traffic analysis. BNSF wants to put in a bridge so they will likely close one RR crossing.

Safety: In Skamania County, accidents and deaths were down in 2011 and 2012 and up from 2013 on. Rural County and Hwy 14 are the worst and it was mostly young people. We follow the state trend.

Hwy 14: Granite will be doing some work on Hwy 14 using recycled asphalt. They need to have 4 days rain free days to test it.

Hotsprings Way has 3 active slides on it.

Weekend Transit: Seasonal transit has begun which takes hikers to the trailheads. Stevenson to Doug Mtn, April – July.

Port of Cascade Locks: Bridge of the Gods has a \$57M plan. Want to keep bridge at 80,000 lbs. Bike pedestrian project on the bridge. Enhancements to super structure. Auto tolls. Seismic study. Welding to be done. They have federal funds for repairs.

LegislativeODOT to work with WSDOT on a comprehensive service plan (if passed). OR is doing a critical freight corridors plan.

A WA RTPO (Regional Trans Planning Org) wants to form and cannot join another. If implemented, our RTC (Regional Transportation Commission) will get a little less money.

Last day of the WA State Legislative session is April 23, 2017.
