New Business-

Discussion on gazebo fees –D. Adams – question is do we want to waive fee for non-profits, etc within our community. T. Jermann – Surrounding parks make reservations for spots, but no fees. T. Randall – charge is because public works cleans up after this and costs money. T. Jermann- use the reserved signs. Ultimately keeping fee. Mayor's discretion to waive fee for groups who talk to him prior. M. Lee- we already are a low-budget town, this is just a little extra for park maintenance.

Insurance/Inspections on Golf Carts- T. Jermann – all other groups of motor vehicles don't require – ATV's, motorized wheelchairs, dirt bikes, lawnmowers, etc... It takes the liability off of the city to inspect and seems more reasonable to not require insurance when all other non- freeway vehicles are allowed.

Discussion on residents mowing 14ft. easements- B. Sabo – no discount, we get to it when we get to it. The city only has so many workers and more pressing things. People can mow their easements if they like, but we cannot guarantee a schedule or give a discount.

Discussion on street parking/when to call sheriff- B. Sabo – at negotiation time for Sheriff mutual aid, will discuss code enforcement. Warning first, then civil infraction- not a legal ticket, but a city fine. Sheriff involvement and fines if further need.

Discussion of hiring temporary/PT front desk assistant – B. Sabo – hired a temp for manning phones/organizing/cleaning until further notice.
