**Consent Agenda:** Approval of the February 14th meeting minutes and the February 2nd half vouchers for \$27,583.92. Motion by T. Randall, second by R. Hall **Passed 5-0** Approval of the February 2<sup>nd</sup> half voucher for R. Hall for \$692.80. Motion by T. Randall, second by T. Norris. **Passed 4-0, R. Hall abstains.**

#### Guest Presentations: N/A

**Public Comment:** Perry Colburn of North Bonneville speaks about his ticket hearing that was dropped because of being cited with the wrong RCW and speaks of the ticket being politically motivated and interactions with Mayor Sabo and Mr. Randall.

**Councilmember Comments:** J. Good comments on a meeting previously held with Perry, questions the hiring process for County Public Works and states he would like to meet with commissioners, and brings up concerns about emergency operations regarding trains due to the Ohio derailment. Greg Johnson, previous Assistant Fire Chief, comments that the emergency operations manual includes that scenario and that the FD is trained on procedures. T. Randall thanks all for coming and expresses concern over youth depression and bullying because of a recent local suicide. Randall also responds to Perry and states that he has a civil duty to report possible violations of all kinds to the Sheriff's Dept.

**Mayor's Comments:** Mayor Sabo responds to Perry's comments and reminds all that Perry was never ticketed by NB official but was only warned on NB Municipal Code.

**Chief Administrative Officer Report:** Deanna comments on Josh's meeting with Mr. Colburn and records requests. She also updates on progress with the new software conversion and issues with current software provider. Deanna also shares progress with Gorge Days sponsors.
