Mayor's Comments: Mayor Sabo mentions the water leak on Columbia. He also was asked if kids could practice roller hockey on the tennis court, but council decided no because of liability, possible damage to the court, and that opens up to other uses. The mayor also mentions a question of whether E. Cascade Drive belongs to the city or even has Easements or Right of Ways.
