Public Comment: Jeff Blakely comments about summer water usage rates, requiring new builds to have irrigation systems, the library levy and library hours in North Bonneville, and the quality of internet service provided by Blue Mountain Networks.

Sheriff's Report: The sheriff commends the NB fire department, gives updates on calls and activities in the city, notes that the frequency of search and rescue calls have continued to climb and that congress woman Gluesenkamp Perez recently reached out to her to discuss this. She also shared about their booth at the fair.

Mayor's Report: Gives an update about lift station two and the problems it is having as well as the cities plan for getting it replaced. Talks about some problematic things getting into to sewer system and the problems that arise from this.

City Clerk Report: Gives updates on asset management system, gives quarterly budget report, gives update on when the biannual audit by the state auditor will begin, and the resolutions occurring in the city's historical 941's filed with the IRS.

City Attorney's Report: Nothing to report tonight.

Planner's Report: Shares he is working on year two of the periodic review and that the grant award is getting dispersed differently due to changes in funding on the state level. Gives updates on utilities on Coyote Ridge. Shares about an upcoming conditional use hearing for chickens and that a contractor is working to put on new manufactured home on Sun Tilikum.
