Approval of September second half voucher for R. Hall professional services in the amount of \$1,371.50: Motion by T. Randall, second by M. Lee. **Passed 4-0, R. Hall abstains.**

Councilmember Comments: R. Hall thanks public works for restriping crosswalks and stop lines. T. Randall thanks all for coming and thanks public works for cleaning up brush along E. Cascade. T. Norris adds that public works has a new addition. Mayor Sabo discusses possible replacement of an old truck with a county truck with a plow for \$7,400 plus tax and licensing and requests permission to bid. J. Good amends motion to not exceed \$7,400 not including taxes and licensing. T. Norris seconds. **Passed 5-0**
- **Confirm Mary Salka to Planning Commission Alternate:** Motion by J. Good, second by M. Lee. **Passed 5-1, J. Good abstains.**
- **Discussion on Planning Commission procedures:** Discussion on planning commission procedure ensues.
