- **Approval of the September 14 Council and Workshop meeting minutes. Approval of the September 2nd half Vouchers for \$27,529.64:** Motion by R. Hall, second by T. Randall. **Passed 5-0**

Public Comment:

Josh Good of NB reminds everyone that road conditions aren't great and there have been many accidents on 14. He wants everyone to stay diligent and "Arrive Alive".

Greg Johnson, Assistant Fire Chief of NB checks out the hydrants around town and wanted council to know that homeowners with private hydrants behind fences need to supply the FD with keys to allow quick response. Greg reports that there were some numbering issues, but PW is going to fix it.

Councilmember Comments: T. Randall thanks all for attending and asks if the city can invest in some attachable hydrant flags so that PW doesn't have to spend so much time marking when it snows. Sabo responds that it is already going to be in the budget. J. Acton asks about if the road reflectors to identify hydrants at night had been talked about again and Sabo responds that it has not, but that it is a good idea. Greg also mentions cars parking in front of hydrants frequently on Island Way and on Ft. Rains.

Mayor's Comments: The Mayor thanks all for coming. He asks for council's ideas about preventing the drinking and smoking on the disc golf course – there were two incidents over the weekend involving these and excessive littering. He suggests a meeting with some of the officials of the disc golf clubs to spread the word that the baskets may be pulled if it continues. T. Randall states that donations alone aren't enough to pay for the hassle. Sabo also mentions that not having advance warning of large groups is becoming a problem, which should also be discussed. He says there needs to be a solution and locals don't need to pay the price.

Chief Administrative Officer Report: CAO Deanna Syron explains that she sent out requests for RFP (request for proposals) regarding choosing new accounting software. Proposals are due on October 13th, then she will select the winner and move forward with purchase.

City Attorney's Report: Ken W. reports that he has helped Deanna with the procedures for RFP, which is different from the regular bidding process and more like a negotiation.

Unfinished Business:

- **CBD City Lot Appraisal approval:** Motion by T. Randall, second by J. Acton. Deanna explains that she

obtained three references for Commercial Appraisers, all of which were around \$2500 and only one of which could make it happen within the next couple months rather than waiting almost a year to be appraised. Councilor Randall restates the motion not to exceed \$2500 and J. Acton seconds.

New Business:

- **City Baseball Field Lights proposal:** Mayor Sabo shares a proposal by Keri Dudley to add lighting to the field for evening games and move out the fence another 40 feet to allow all levels to play. The area in which they would like to extend the fence is part of the Life Flight Landing Zone and would need to be discussed. Council is not opposed to the idea as long as logistically able.
- **City Playground Play Structure and Swing set Proposal:** Deanna explains that this is not a proposal, but just showing council the top choices in equipment decided on by the playground committee. The next meeting on Tuesday, October 5th, will be to decide on placement within the area. Council asks Deanna to find out about delivery time, freight cost, taxes, and installation costs with the quote to present at the next meeting.
