Josh Good, PDA Audit Report to the Council: B. Sabo – we recently put together a committee consisting of myself, J. Acton, T. Jermann, and J. Good regarding the position of the PDA and possible sale. Josh is presenting the findings. Josh Good -There are people here who care and have done their best. We looked at some history and the state of the business, wanting to provide some direction for the future. Reports show that recent losses are reversable and we are starting to see some profits. There have been recent attempts to cut costs, especially in payroll. In general, the recordkeeping of the PDA have been vague at best. There have been improvements over the last year. There is a conflict of interest between people with vested interest and those who handle the finances. This creates a grey area for whose interest is being looked out for. I want to make clear that this report doesn't blame or suggest wrongdoing, just trying to make things clear. I think the city has options for addressing some of the challenges; could be sold today, but because of the conflict of interests, it would be hard to determine a fair market price. The PDA board must display the same interests as the city. There needs to be increased accountability in PDA reporting. The PDA really needs to be transparent in reporting and communications and meet more than quarterly. There were great policies put in place in the beginning of the PDA creation, but the policies have gotten away from them and there have been some ethics put into question. Ken W states that we may need to canvas the community for replacement board members. The sooner the better. B.
