#### Guest Presentations:

- **Bonneville Trails Foundation Adventure Park Presentation:** Greg and Ken of the Bonneville Trails Foundation discuss further plans for the proposed Adventure Park project and present an updated slideshow and options for initial funding. B. Sabo highlighted that council approved to earmark the \$250k reserved for tourist facility for this project with the understanding that it will not be released until they have raised the other funds. Tourist facility dollars have a very specific use and have been sitting there for several years waiting on a good project. There will be more opportunity for public meetings prior to any start on the project. Please refer to recording for full narrative. Cheri Mazzola of NB asks why this first rather than developing the business district. Greg and Mayor Sabo respond that businesses have come and gone due to a lack of draw for tourists and the small population of the citizens alone not being enough to sustain them. City Attorney, Ken Woodrich, states that there needs to be an agreement written up outlining the responsibilities and funding commitments of both parties and a separate agreement regarding refunding of sponsors if something falls through.

**City Clerk Report:** Deanna mentions that we started with govpaynet for an online payment options for utilities. You can now make payments online for a fee through the city website.
