Garden Fees:

Garden plots are **\$30.00** per year for a 5'X20' plot and **\$20.00** per year for either, a L-shaped or a 7'X7' plot, payable by cash, check or credit card. Please make check payable to the City of North Bonneville. One time key deposit of **\$5.00** will be refunded at the time you no longer wish to renew your plots and return your key. Lost key replacements are **\$3.00**. Only one plot per family will be assigned, however after April 15 any remaining unassigned plots will be available on a first come first serve basis up to a maximum of 2 plots per person and/or family. After May 15, exceptions will be considered on a first come first serve basis of any unclaimed plots in regards to the maximum number of plots rule. If granted, this exemption expires with the season.
