

**CITY OF NORTH BONNEVILLE  
ORDINANCE NUMBER 1123**

**AN ORDINANCE OF THE CITY OF NORTH BONNEVILLE, WASHINGTON,  
AMMENDING CHAPTER 2.08 APPOINTIVE OFFICES.**

**WHEREAS**, the City of North Bonneville is an optional municipal code city organized and existing under the provisions of Title 35A of the Revised Code of Washington; and

**WHEREAS**, the City previously passed Ordinance 1101 which authorized the separation of the position of Administrator/Clerk/Treasurer into the positions of City Clerk/Treasurer and Office Manager; and

**WHEREAS**, the City wishes to combine these titles into one position that better reflects the current responsibilities of the position;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BONNEVILLE, WASHINGTON DO HEREBY ORDAIN AS FOLLOWS:**

CHAPTER 2.08 Appointive Offices as follows:**

- 2.08.010    ~~Administrator/Clerk/Treasurer separated into the positions of City Clerk/Treasurer and Office Manager~~ Chief Administrative Officer.**
- 2.08.020    Appointment.**
- 2.08.025    Compensation.**

**2.08.005    Offices.**  
In accordance with RCW 35A.12.020, the City shall provide ~~two appointive offices, the office of City Clerk/Treasurer and the office of the Office Manager~~ for the merger of the appointive offices of City Clerk and City Treasurer to be titled Chief Administrative Officer.

**2.08.010    ~~Administrator / Clerk / Treasurer separated into the positions of City Clerk/Treasurer and Office Manager.~~ Chief Administrative Officer.**  
Pursuant to Section 35A.12.020 of the Revised Code of Washington, ~~the office of Administrator/Clerk /Treasurer is hereby separated into the positions of City Clerk/Treasurer and Office Manager.~~ The City creates the position of Chief Administrative Officer.

**2.08.020    Appointment.**  
~~The offices of City Clerk /Treasurer and Office Manager~~ position of Chief Administrative Officer shall be appointed by and shall hold office at the pleasure of the Mayor, upon confirmation of the City Council.

**2.08.025 Compensation.**

The compensation of the ~~City Clerk/Treasurer shall be \$47,400 [annually] and the compensation of the Office Manager shall be \$35,000 [annually].~~ Chief Administrative Officer ~~These compensations shall be modified from time to time shall be set through the annual budgetary process or according to an adopted pay plan.~~

**Section 2.**

**Severability.**

If any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Effective Date and Publication.**

This Ordinance shall be effective five days after publication of the Ordinance, or a summary thereof consisting of its title, in the official newspaper of the City.


