

**CITY OF NORTH BONNEVILLE
ORDINANCE NUMBER 1091**

AN ORDINANCE OF THE CITY OF NORTH BONNEVILLE, WASHINGTON, AMENDING NORTH BONNEVILLE MUNICIPAL CODE CHAPTER 5.04 BUSINESS LICENSES AND REGULATIONS, CHAPTER 6.04 ANIMAL CONTROL, CHAPTER 8.32 OUTDOOR BURNING AND CHAPTER 12.12 PATHWAYS – MOTORIZED VEHICLES.

WHEREAS, it is the desire of the City to have fees from the municipal code removed and referenced by resolution of the City Council; and

WHEREAS, review and updating of the fees in these titles is needed to better address the true costs of these services; and

NOW, THEREFORE, The City Council of the City of North Bonneville does hereby ordain as follows:

Section 1.

Amending

CHAPTER 5.04 Business Licenses and Regulations as follows:

5.04.040 Fees.

A. The license fee ~~shall be twenty five dollars (\$25.00) per calendar year, or any portion thereof,~~ for those businesses operating or conducting business from a permanent location within the City shall be set by resolution of the City Council. "Permanent location" shall refer to any business operating or conducting its business from a fixed location with a mailing address for a continuous period of at least thirty (30) days.

B. The license fee for a "transient merchant and door to door solicitor" shall be ~~ten dollars (\$10.00) per day of twenty five dollars (\$25.00) per calendar year~~ as set by resolution of the City Council.

~~C. Any business license renewed after March 1st shall cost fifty dollars (\$50.00).~~

Section 2.

Amending

CHAPTER 6.04 Animal Control as follows:

Section 6.04.020 Licenses, fees, tag specifications, expiration.

The dog license referred to in Section 6.04.010 shall be an annual license and shall expire at midnight on the thirty-first day of December of the year for which it was issued. The license shall be a metal tag, bearing an identification number, the words "North Bonneville" and a designation of the year the license was issued. The license tag shall be attached to a dog collar and the license shall be worn by the licensed dog at all times.

~~License fee schedule:~~ fees shall be as set by resolution of the City Council.

~~A. The annual license fee for unneutered or unspayed dogs shall be ten dollars (\$10.00).~~

~~B. For residents who obtain a dog on or after July 1st, or for new residents to the city on or after July 1st, the license fee shall be reduced to one half of the annual fee.~~

~~C. For dog owners aged sixty-five (65) or older, the annual license fee shall be one dollar (\$1.00).~~

~~D. The annual fee for a neutered or spayed dog shall be three dollars (\$3.00), upon written proof provided by the owner that the dog is neutered or spayed.~~

~~E. Licenses purchased for the redemption of a dog shall be ten dollars (\$10.00) regardless of the date, age of owner, or proof of neuter or spay.~~

~~F. Licenses shall be required for all service dogs and service dogs in training. Upon receipt of official documentation, the fee for the license shall be waived.~~

Section 6.04.050 Dogs limited.

A. No person, firm, family, household or entity will keep or maintain, within the city limits of North Bonneville, an excess of two (2) or more dogs four (4) months or older without a valid kennel license issued by the city.

~~B. Any person, firm, family, household or entity currently a resident of the City of North Bonneville having more than two (2) dogs licensed by the city, at the passage of the ordinance codified in this chapter will be allowed to keep and maintain such dog(s) in excess of two (2) until the death of such dog(s) or until they are otherwise disposed of by the owner.~~

Section 6.04.150 Kennels--Definitions.

As used in this chapter:

"Commercial kennel" means any establishment or premises, other than veterinary hospitals or pet shops, where three (3) or more dogs are kept for commercial purposes, including but not limited to boarding, propagation and treatment.

"Hobby kennel" means any establishment or premises where three (3) or more dogs over four (4) months of age are kept for noncommercial purposes or for any purpose other than those distinguishing a "commercial kennel" as defined herein.

Section 6.04.160 Kennels--License required.

It is unlawful to keep or maintain a commercial or hobby kennel within the city limits without having first obtained a valid license. Fees for kennel licenses shall be as set by resolution of the City Council.

~~Commercial kennel license — \$25.00/year~~

~~Hobby kennel license — \$10.00/year~~

The kennel license fee shall be assessed upon the owner or keeper of such dogs and shall expire on the thirty-first day of December of the year in which it is issued. The fee shall not be prorated except that if the original application for license is made on or after July 1st, a fee equal to one-half of the specified license fee shall be accepted.

In addition, each animal shall be licensed individually as provided in this chapter.

Section 3.

Amending

CHAPTER 8.32 Outdoor Burning:

8.32.030 Permit fee.

The permit fee shall ~~five dollars (\$5.00)~~ be as set by resolution of the City Council.

A. Open burning permits will be provided by the City. A record of the permit will be maintained by the City in a file to be called "open burning permit record." Open burning permits may be obtained by personal request.

B. The Fire Chief may prohibit any or all open fires when, in his/her sole discretion, atmospheric conditions, air pollution conditions or other local circumstances make such fires hazardous or create an air contamination problem.

Section 4.

Amending

CHAPTER 12.12 Pathways – Motorized Vehicles:

12.12.040 Golf cart permits.

Golf carts shall be subject to an annual permit fee of ~~twenty dollars~~ as set by resolution of the City Council and must be inspected and approved by a representative authorized by the city. Proof of liability insurance must be presented at the time of inspection and be in the operator's possession when operating on city property or property open to the public. Golf carts are only authorized to cross a city street to get to another public pedestrian pathway. They shall not travel over 100 feet in either direction on a city street, except for the Hamilton Creek Bridge on Cascade Drive where crossing will be allowed. Minimum age to operate a golf cart shall be sixteen (16) years.

Section 5

Severability.

If any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

Section 4.


Effective Date and Publication.


This Ordinance shall be effective five days after publication of the Ordinance, or a summary thereof consisting of its title, in the official newspaper of the City.


