**A RESOLUTION OF THE CITY OF NORTH BONNEVILLE, WASHINGTON,  
DECLARING CERTAIN PROPERTY TO BE SURPLUS, ESTABLISHING A VALUE  
AND METHOD OF DISPOSAL OF SUCH PROPERTY.**

**WHEREAS**, trees on city land occasionally die and need to be removed to maintain the aesthetics and/or safety of that property; and

**WHEREAS**, allowing private citizens to remove such trees for their own uses can save the city time and money; and

**WHEREAS**, the City is authorized by RCW 35A.11.010 to establish a value of its property and to authorize sale of the same by resolution passed by the City Council of North Bonneville;

**NOW, THEREFORE, BE IT RESOLVED THAT** the City of North Bonneville hereby declares as surplus all identified dead trees on city land that have fallen or are clearly damaged and hazardous as determined by the city. The value of these trees is hereby set as equivalent to the cost of their removal. The City further authorizes the removal of these trees by private citizens on a first come, first serve basis and upon their signing of a hold harmless agreement providing indemnity to the City (attached).
